HOW TO ENTER. Each time you use your Jewel-Osco Preferred Card and purchase (2) 12 packs of Dr Pepper Product(s) during the Sweepstakes Period at participating Jewel-Osco stores in the Sweepstakes, you are automatically entered for a chance to win. If you do not have a Preferred Card, you may complete an application for one, free of charge, at the Customer Service desk of the participating Jewel-Osco. It is each participant's responsibility to ensure that

his or her Preferred Card data is up to date. If multiple users of the same Preferred Card enter and a dispute arises regarding the identity of the entrant, the authorized subscriber shall be deemed to be the entrant.

FREE ENTRY: Complete an official entry form or on a 3" x 5" card hand print your actual name and residential address (as they appear on your driver's license or governmental identification) (no P.O. boxes), telephone number and date of birth, and deposit in official entry box (if available) or submit in a #10 envelope to the Free Entry Address. Entry forms must be legible and completed in full to be valid. Machine duplicated or reproduced entries will not be accepted. Only one individual's name may be on each entry form and only one entry form per envelope. Not responsible for lost, late, damaged, misdirected, illegible, postage-due mail or human or other error that may occur in the receipt or processing of entries. Entries become property of Sponsor and will not be returned. Entries must be received by the Entry Receipt Deadline.

No Automated Entries. You must fill out your own entry form without the use of any automated sweepstakes entry filling services or form filling services. The use of any automated, programmed, robotic or similar system to enter is prohibited and will result in disqualification. Entries filled out by anyone other than you will be disqualified. Auto entries prohibited.

Winner will be notified by phone, mail or email within one week of the drawing; if after a reasonable number of attempts during a day (as determined by Administrator in its sole discretion) contact is not made with winner, prize will be forfeited and an alternate winner selected.

PRIZE NOTIFICATION: Winner will be notified by phone and/or mail within one week of the drawing; if after a reasonable number of attempts during a day (as determined by Sponsor or Administrator in its sole discretion) contact is not made with winner, prize will be forfeited and an alternate winner selected. Winner may be required to sign an affidavit of eligibility and release of publicity/liability ("**Affidavit**") within the time period specified by Sponsor or Administrator in the letter accompanying the Affidavit ("**Prize Letter**") or prize will be forfeited. If mail is returned as undeliverable without a forwarding address, then prize may be forfeited. An alternate winner for forfeited prizes may be selected at Sponsor's sole discretion. Prize will be awarded upon receipt of Affidavit, and verification of prize winner. Any required Affidavits or other documents must be signed by parent/legal guardian of a minor in his/her state of residence.
