Dr Pepper Pick Your Pepper Program Terms and Conditions

1. Eligibility

Dr Pepper Pick Your Pepper Program (“Program”) begins Friday, June 15, 2018, at 12:00:00 AM Eastern Time (“ET”) and ends August 15, 2018, at 12:00:00 AM ET or until 209,293 Rewards (as detailed below) are awarded or on Wednesday, August 15, 2018, at 11:59:59 PM ET, whichever is earlier (“Reward Period”). Participation in the Program is only open to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older. **Limit of up to two (2) Rewards (as detailed below) per person.**

2. Reward Program

Participants may participate in the Program by purchasing at least three (3) eligible Dr Pepper products (listed in the Appendix below) from any retailer during the Reward Period (“Qualifying Purchase”). Participants who make a Qualifying Purchase and submit up to three (3) different photos of the purchased Dr Pepper products will receive one (1) branded T-shirt (“Reward”). Approximate Retail Value (“ARV”) of each Reward is \$8.25.

3. How to Participate

Make a Qualifying Purchase and submit one (1) photo of a receipt with three (3) purchased Dr Pepper product(s) or up to three (3) photos over the course of the “Reward Period”; each photo must include at least one (1) eligible Dr Pepper product (“Product Photos”). All submissions of Product Photos must be received by Wednesday, August 15, 2018, at 11:59:59 PM ET to be eligible. Product Photos must clearly show the store receipt in its entirety including name of the retailer, product(s) you are buying, and date of purchase. Participants should keep their store receipt(s) until verification is complete. Dr Pepper/Seven Up, Inc. (“Sponsor”) reserves the right to require a participant to provide original store receipt for verification purposes upon request. Participants can submit their Product Photos by texting the keyword “**DRPEPPER**” to **64827**. Participant will first receive a text message with opt-out instructions and disclosure for receipt of up to fifteen (15) automated text messages to the number provided, along with instructions for Product Photo submission. Limit of 160 characters per text.

4. Redemption

Participants must submit valid Product Photos via the method above to receive a Reward. Rewards are subject to provider’s full terms and conditions. Upon receipt and verification of the Qualifying Purchase, participants will be sent redemption instructions via text to the phone number used during submission.
